#### Lombard Street

Known as the "Crookedest Street in the World," Lombard Street is one of San Francisco's most popular landmarks. Every year, millions of visitors walk or drive down its eight sharp hairpin turns. Surrounded by Russian Hill mansions and perfectly manicured landscaping and flowers, it is also one of the city's most scenic streets. Take a spectacular photo at the bottom looking up or enjoy the breathtaking view from the top looking out onto the San Francisco Bay, the Bay Bridge and Coit Tower.

The Sundial Bridge at Turtle Bay is a world-famous pedestrian bridge and public art installation that crosses the Sacramento River in Redding and connects the north and south campuses of Turtle Bay Exploration Park. As the name suggests, the Sundial Bridge is, in fact, a working sundial and is one of the largest in the world. The sundial shadow traces such a large arc that it can record only four hours a day, from 11am - 3pm. It is not accurate in winter because the shadow is too far into the arboretum to be seen. The bridge celebrates human creativity and ingenuity, important themes of the 300 acre Turtle Bay Exploration Park. The steel, glass, and granite span evokes a sense of weightlessness and the translucent, non-skid decking provides for spectacular viewing at night. The bridge is also environmentally sensitive to its river setting.
